



## **RE: RESOLUTION OF THE NIXA CITY COUNCIL CONFIRMING THE APPOINTMENTS OF BRIAN POPEJOY AND MATT LANDER TO THE PLANNING AND ZONING COMMISSION**

### **Background:**

At the September 26, 2022, City Council meeting, Matt Ogden was appointed to City Council and resigned from his position on the Nixa Planning and Zoning Commission. Mayor Brian Steele has appointed Brian Popejoy to serve the remainder of the term vacated by Mr. Ogden.

Matt Lander is a current Nixa Planning and Zoning Commissioner with a term set to expire November 2022. He wishes to continue to serve on the Planning and Zoning Commission.

### **Analysis:**

Brian Popejoy will serve a four-year term on the Nixa Planning and Zoning Commission, ending on November 1, 2026.

Matt Lander will serve a four-year term on the Nixa Planning and Zoning Commission, ending on November 1, 2026.

**A RESOLUTION OF THE COUNCIL OF THE CITY OF NIXA CONSENTING TO THE MAYOR’S APPOINTMENT OF BRIAN POPEJOY AND MATT LANDER TO THE PLANNING AND ZONING COMMISSION.**

**WHEREAS** Matt Ogden was appointed to the Planning and Zoning Commission on January 28, 2022, by Resolution 2022-014; and

**WHEREAS** Mr. Ogden was appointed to serve until November 1, 2022; and

**WHEREAS** on September 26, 2022, Mr. Ogden was appointed to fill the vacant District 1 City Council position; and

**WHEREAS** at the time of Mr. Ogden’s appointment to City Council, a vacancy occurred on the Planning and Zoning Commission; and

**WHEREAS** the Mayor has appointed Brian Popejoy to serve on the Planning and Zoning Commission for the term beginning November 1, 2022, and ending on November 1, 2026; and

**WHEREAS** Matt Lander was appointed to the Planning and Zoning Commission at the July 27, 2020, City Council meeting, to serve the remainder of Chance Peebles unexpired term; and

**WHEREAS** the Mayor has appointed Matt Lander to serve a on the Planning and Zoning Commission for a term beginning November 1, 2022, and ending on November 1, 2026; and

**WHEREAS** the City Council hereby consents to the Mayor’s appointments as provided for herein.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:**

**SECTION 1:** The City Council hereby consents to the Mayor’s appointment of Brian Popejoy to the City’s Planning and Zoning Commission. Mr. Popejoy’s term shall begin on November 1, 2022, and shall expire on November 1, 2026.

**SECTION 2:** The City Council hereby consents to the Mayor’s appointment of Matt Lander to the City’s Planning and Zoning Commission. Mr. Lander’s term shall begin on November 1, 2022, and shall expire on November 1, 2026.

**SECTION 3:** This Resolution shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions of section 3.11(g) of the City Charter.
