

Issue: A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF NIXA, MISSOURI AUTHORIZING A PUBLIC

FIREWORKS DISPLAY SPONSORED BY THE NIXA CHAMBER OF COMMERCE AND LOCATED AT

THE NIXA HIGH SCHOOL JUNE 25, 2022

Background

The Nixa Chamber of Commerce has applied for a special event known as the Sky-High Fireworks Celebration that involves a public fireworks display. The Nixa City Code provides for permits for the public display of fireworks when authorized by the City Council and subject to the requirements found in Sections 16-198 and 16-199.

The 2022 Sky-High Fireworks Celebration is scheduled to take place on June 25, 2022, at roughly 9:30pm at the Nixa High School Eagle Stadium located at 514 South Nicholas Road. The Nixa Chamber of Commerce has hired Encore Pyrotechnics to conduct the display.

Analysis

Section 16-198 and 16-199 of the Nixa City Code provides for the following regulations in conducting a public fireworks display.

- A permit shall be granted for supervised public displays.
- The display shall be handled by a competent operator approved by the City Council.
- The display shall be of a character and so located and conducted so as, in the opinion of the City Council after proper investigation, not to be hazardous to property or endanger any person.

The location and character are presumably acceptable given prior authorization of similar displays at the same location. As evidence of the competence of the operator, the Nixa Chamber of Commerce has cited that Encore Pyrotechnics has successfully and safely operated similar shows for Big Cedar Lodge, College of the Ozarks, and Missouri State University.

The display is planned to commence at a time near 9:30pm, when the sky becomes sufficiently dark, and the display will last for approximately 12-15 minutes.

Recommendation

Staff recommends the approval of the Sky-High Fireworks Celebration display.

A RESOLUTION OF THE COUNCIL OF THE CITY OF NIXA GRANTING A PERMIT TO THE NIXA AREA CHAMBER OF COMMERCE TO AUTHORIZE THE DISPLAY OF FIREWORKS.

WHEREAS Nixa City Code section 16-197 generally prohibits the discharge or use of any firework within the City; and

WHEREAS Nixa City Code section 16-198 authorizes the City Council to grant permits authorizing the supervised public display of fireworks by certain organizations notwithstanding section 16-197 of the City Code; and

WHEREAS the Nixa Area Chamber of Commerce (the "Applicant") has requested a Permit to engage in the supervised public display of fireworks on June 25, 2022, at approximately 9:30 pm at the Nixa High School Eagle Stadium, generally located at 514 South Nicholas Road; and

WHEREAS the Applicant has hired Encore Pyrotechnics to conduct the display; and

WHEREAS the City Council desires to issue a Permit for such activity, as authorized by Nixa City Code section 16-198 and upon the terms and conditions provided for herein.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:

SECTION 1: City Council hereby grants a Permit to the Applicant, pursuant to Nixa City Code section 16-198, authorizing the supervised public display of fireworks, provided that such display fully complies with the terms and conditions of this Resolution. The Permit granted herein authorizes the Applicant to discharge any firework at the Nixa High School Eagle Stadium, being generally located at 514 South Nicholas Road. Such discharge shall be conducted by individuals appropriately licensed by the state fire marshal, and any other applicable governmental entity, to conduct the display.

SECTION 2: The Permit granted herein authorizes the Applicant, or their authorized agent, to discharge fireworks on June 25, 2022, at approximately 9:30 pm, or when conditions are sufficiently dark to proceed with the display.

SECTION 3: The authorization granted herein is subject to all applicable provisions of the Nixa City Code, including without limitation City Code sections 16-198, 16-199, & 16-200. Additionally, the authorization granted herein is expressly subject to all applicable provisions of the City's adopted Fire Code and any other applicable state or local laws. The Applicant shall obtain any necessary approvals of the Nixa Fire Protection District, or any other governmental entity, before engaging in the activities authorized by this Resolution.

SECTION 4: The City Administrator is hereby authorized to impose any additional requirements or conditions on the Permit granted herein that, in the reasonable judgment of the City Administrator, are warranted to protect the health, safety, and welfare of the residents of the City. The authorization granted to the City Administrator in this Section includes the authority to revoke or temporarily suspend the Permit granted herein if, in the City Administrator's reasonable judgment, the discharge of fireworks by the Applicant would unreasonably harm the health, safety, and welfare of the residents of the City. Additionally, the City Administrator is authorized to do all things necessary or convenient to carry out the intent and terms of this Resolution.

SECTION 5: The Applicant shall obtain the written approval of the City Administrator before engaging in the display or discharge of fireworks pursuant to this Permit. The City Administrator shall provide their written approval of the requested display or discharge unless, in the City Administrator's reasonable judgment, the requested discharge of fireworks by the Applicant would unreasonably harm the health, safety, and welfare of the residents of the City.

SECTION 6: This Resolution shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions of section 3.11(g) of the City Charter.
