RE: Second Reading Council Bill #2021-073 Calling for an Election; and Amending
the 2021 Annual Budget for Said Election
Date: August 2, 2021

As you all are aware, on June 28th, 2021, the City Clerk's Office received a recall petition submitted by the petitioner's committee. This petition called for the recall of Brian Steele, Mayor of Nixa, Missouri. On June 29th, the petition was sent to the Christian County Clerk's Office to verify the number of signatures. Of the ninety-seven (97) signatures submitted on the petition, seventy-three (73) signatures were verified as registered, inside-city voters. In accordance with Nixa's Home Rule Charter, Section 10-4(a), on July 14th I sent a certificate of sufficiency for the recall petition to the committee via certified mail.

Section 10-6 (c) of the Home Rule Charter states that once a recall petition has been certified to Council as sufficient by the City Clerk, the Council shall, at its next meeting after receipt of such certification, fix a date for holding the election. The election shall be held at the next available regular or special election date as established by the Missouri election calendar in accordance with State law, for which timely notice may be given.

This evening I have for your consideration the final reading of Council Bill #2021-073 calling for an election on November 2, 2021, recalling the Mayor. Also included in this ordinance is a request for a budget amendment of \$15,000.00 for anticipated costs for this election. I am merely basing this estimation on the election in April 2021. Should the costs of the November election exceed \$15,000.00, I will bring back another budget amendment to cover those costs. If the ordinance is approved this evening, I will be sending ballot information over to Christian County because the certification deadline for the November election is August 24, 2021.

9 **WHEREAS** Section 10.1 of the Charter of the City of Nixa, grants the qualified
10 voters of the City the power to recall elected officials of the City; and

11
12 **WHEREAS** Section 10.2 of the City Charter provides that any five qualified
13 voters may commence a recall proceeding by filing with the City Clerk a notarized
14 affidavit stating they will constitute the petitioner's committee and be responsible for
15 circulating the petition; and

16
17 **WHEREAS** Section 10.3 of the City Charter requires that a recall petition shall be
18 signed by a number of qualified voters equal to ten percent of the total number of votes
19 cast for the office in the election at which that office was elected; and

20
21 **WHEREAS** on June 28, 2021, the City Clerk's Office received a recall petition
22 submitted by the petitioners' committee calling for the recall of Mayor Brian Steele, said
23 petition being attached hereto as "Council Bill Exhibit A"; and

25 **WHEREAS** the Christian County Clerk's office has provided verification that, of
26 the 97 signatures submitted on the petition, 73 were verified as registered voters
27 residing within the City; and

28
29 **WHEREAS** on July 14, 2021, pursuant to City Charter Section 10.4, the City
30 Clerk provided a certificate of sufficiency to the petitioners' committee stating that the
31 submitted petition contained sufficient signatures, said certification being attached
32 hereto as "Council Bill Exhibit B"; and

34 **WHEREAS** Section 10.6 of the City Charter states that when a recall petition has
35 been certified as sufficient by the City Clerk, the Council shall fix a date for holding the
36 recall election; and

37
38 **WHEREAS** Section 9.1 of the City Charter requires the Council to call special
39 elections by ordinance; and

40
41 **WHEREAS** the next available election date, as determined by the election laws
42 of the State of Missouri, is November 2, 2021; and

44 **WHEREAS** City Council desires amend the 2021 Annual Budget in the amount
45 of \$15,000.00 to provide funding for the estimated cost associated with said election.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:

SECTION 1: The City Council hereby calls and orders that a special election shall be held within the City of Nixa, on November 2, 2021, for the purpose of submitting to the qualified voters of the City the question of whether to recall Mayor Brian Steele.

SECTION 2: The ballot to submit the question referenced in Section 1 herein, shall be in substantially similar form as the following:

Shall Brian Steele, Mayor of the City of Nixa, be removed from office?

INSTRUCTIONS TO VOTERS:

If you are in favor of removing Mayor Brian Steele from office, mark the box opposite "Yes."

If you are opposed to removing Mayor Brian Steele from office, mark the box opposite "No."

SECTION 3: The City Clerk is hereby authorized and directed to notify the Christian County Clerk of the adoption of this Ordinance as soon as practicable, but no later than 5:00 p.m. on the tenth Tuesday prior to November 2, 2021. The City Clerk shall include in said notification all the terms and provisions required by Chapter 115, RSMo. or any other law. The City Clerk is further authorized and empowered to do all things which are necessary or convenient to ensure that the question referenced in Section 1 herein is properly and timely submitted to the qualified voters on November 2, 2021.

SECTION 4: The City of Nixa's 2021 Annual Budget is hereby amended in the accounts and the amounts shown on "Council Bill Exhibit C," which is attached hereto and incorporated herein by this reference. City Council finds that the budget amendment enacted by this Ordinance has been recommended by the City Administrator. The City Administrator is directed to cause the appropriate accounting entries to be made in the books and records of the City to reflect the budget amendment enacted by this Ordinance.

SECTION 5: This Ordinance shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions of section 3.11(g) of the City Charter.


Now comes the undersigned, citizens and registered voters of Nixa Missouri, within Christian County, who having been duly sworn upon oath and for their Affidavit states as follows:
