RE: Second Reading Council Bill #2021-076 - Budget Amendment for Outstanding Invoice

from 2014

The attached Bill authorizes a budget amendment in the Water Fund to cover a long outstanding bill for maintenance work on Water Tower #5.

In April of 2014, the City solicited bids to complete maintenance and inspection work to Water Tower #5. Utility Services Co. (USC) was awarded the bid to complete interior inspection and painting as well as touch up work on the rest of the tower. The contractor completed their work and left the job site but failed to meet the standards we expect. City crews had to follow up with cleanup operations such as removing a sand pile left from sandblasting the interior bowl and other job site cleanup. The company also, did not provide an inspection report as required by the contract specifications, nor did they send an invoice for the work.

Through at least October of 2015, Milton Dickensheet had numerous conversations and emails with the company asking for both the report and final invoice in the amount of \$43,340. Mr. Dickensheet also sent a certified letter requesting the same on October 15th of that year. The City had carried over the funds in the 2015 budget anticipating closure of the project and receipt of both the report and invoice. That did not happen.

Fast forward to May 4th of this year when the city received a request from USC for final payment of the outstanding bill. Following several conversations and emails between staff and USC, the company finally sent an invoice, dated October of 2015 along with an after the fact report.

Though the report does not meet the requirements originally set out, we have been advised to make the payment. Because this has not been carried over in the budget since 2015, staff request a budget amendment for the amount so we can close out the issue.

Staff recommends passage of Council Bill #2021-076.

AN ORDINANCE OF THE COUNCIL OF THE CITY OF NIXA AMENDING THE 1 2021 ANNUAL BUDGET TO APPROPRIATE FUNDING FOR AN OUTSTANDING 2 INVOICE FOR MAINTENANCE WORK ON WATER TOWER #5. 3 4 5 WHEREAS in April of 2014, the City solicited bids for the maintenance and 6 inspection of Water Tower #5; and 7 8 WHEREAS Utility Service Co. was awarded the contract to complete the work 9 and did not provide a final invoice for the work; and 10 11 WHEREAS the City's repeated requests for Utility Service Co. to provide a final 12 invoice for the work went unanswered; and 13 14 WHEREAS Utility Service Co., on May 4, 2021, has finally provided a final 15 16 invoice for the work; and 17 WHEREAS because it was not anticipated that this invoice would be issued, the 18 19 City does not currently have funds budgeted to pay this invoice; and 20 WHEREAS Section 67.040 RSMo. provides that after a budget has been 21 approved no increase in the revenues or expenditures from any fund shall be made 22 unless the governing body adopts a measure setting forth the facts and reasons making 23 the increase necessary and authorizing the increase; and 24 25 26 WHEREAS Section 8.7 of the City Charter authorizes the City Council to amend budgeted revenues and expenditures upon the request of the City Administrator; and 27 28 WHEREAS the City Administrator has requested a budget amendment in the 29 amount of \$45,925.00 and for the purposes contemplated by this Ordinance; and 30 31 WHEREAS the City Council desires to amend the City's 2021 budget for the 32 33 purposes identified herein. 34 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF 35 36 **NIXA. AS FOLLOWS. THAT:** 37 **SECTION 1:** The City of Nixa's 2021 Annual Budget is hereby amended in the 38 39 accounts and the amounts as shown on "Council Bill Exhibit A," which is attached hereto and incorporated herein by this reference. 40 41 42 **SECTION 2:** City Council finds that the budget amendment enacted by this Ordinance has been recommended by the City Administrator. The City Administrator is 43 directed to cause the appropriate accounting entries to be made in the books and 44 45 records of the City to reflect the budget amendment enacted by this Ordinance. 46
