Re: Community Center Roof Renovation/Restoration Budget Amendment and Contract Award

As a part of the Capital Improvements for the 2021 year a roof renovation and restoration to the flat roofs of the community center was included. We have bid this project to be completed this fall and received 4 bid responses to our RFP. All the bid respondents came in over budget with the low bidder's quote being a total of \$112,342.00. Our 2021 budget for the project was \$100,000, thus requiring a budget amendment for the completion of this project. To complete the project, we are requesting a budget amendment in the amount of \$12,342.00.
