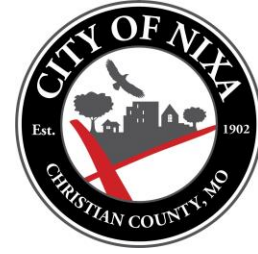

**A RESOLUTION OF THE COUNCIL OF THE CITY OF NIXA AUTHORIZING  
THE CITY ADMINISTRATOR TO APPLY FOR AND ACCEPT GRANT FUNDING  
PROVIDED BY THE NIXA COMMUNITY FOUNDATION TO SUPPORT THE  
POLICE DEPARTMENT'S CITIZEN POLICE ACADEMY PROGRAM.**

**WHEREAS** the Nixa Community Foundation provides grant funding to various organizations within the community; and

**WHEREAS** the City Council desires to apply for said grant funding to assist the Police Department in acquiring supplies to support the Citizen Police Academy program; and

**WHEREAS** the City Council wishes to authorize the City Administrator to apply for and accept up to \$1,500.00 in grant funding for the purposes described in this Resolution.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:**

**SECTION 1:** The City Administrator, or designee, is hereby authorized to apply for and accept grant funding in an amount up to \$1,500.00 from the Nixa Community Foundation to provide supplies for the Police Department's Citizen Police Academy program. The City Administrator is authorized to do all things necessary or convenient to apply for and accept said funding and to carry out the terms of this Resolution, including the execution of documents required to obtain said funding.

**SECTION 2:** This Resolution shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions of section 3.11(g) of the City Charter.
