WHEREAS the Nixa Community Foundation provides grant funding to various organizations within the community; and WHEREAS the City Council desires to apply for said grant funding to assist the Parks Department in acquiring additional audio equipment to support the Movies in the Park program; and WHEREAS the City Council wishes to authorize the City Administrator to apply for and accept up to \$1,500.00 in grant funding for the purposes described in this Resolution. NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF **NIXA, AS FOLLOWS, THAT: SECTION 1:** The City Administrator, or designee, is hereby authorized to apply for and accept grant funding in an amount up to \$1,500.00 from the Nixa Community Foundation to assist the Parks Department's acquisition of audio equipment for use with the Movies in the Park program or other purposes. The City Administrator is authorized to do all things necessary or convenient to apply for and accept said funding and to carry out the terms of this Resolution, including the execution of documents required to obtain said funding. SECTION 2: This Resolution shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions of section 3.11(g) of the City Charter.
