Background

The terms of current Nixa Planning and Zoning Commissioners Sarah Bader and Robert Wilson are soon expiring, and they have both been nominated for reappointment by Mayor Steele.

**A RESOLUTION OF THE COUNCIL OF THE CITY OF NIXA APPROVING CERTAIN
MAYORAL APPOINTMENTS TO THE PLANNING AND ZONING COMMISSION.**

WHEREAS the City of Nixa is required to maintain a Planning and Zoning Commission pursuant to Chapter 89 RSMo. and Chapter 101, Article II, Division 2 of the City Code; and

WHEREAS section 89.320 RSMo requires that members of the Planning and Zoning Commission be appointed for four-year terms; and

WHEREAS said members are appointed by the mayor with the approval of the city council; and

WHEREAS the Mayor desires to reappoint Sarah Bader and Robert Wilson to the Planning and Zoning Commission; and

WHEREAS the City Council desires to approve of the Mayor's appointments.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:

SECTION 1: The City Council hereby approves of the following Mayoral appointments to the Planning and Zoning Commission:

1. Sarah Bader, with their term to expire on November 30, 2025.
2. Robert Wilson, with their term to expire on November 30, 2025.

SECTION 2: This Resolution shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions of section 3.11(g) of the City Charter.
