Background

On November 2, 2021, a special election was held in Nixa, Missouri. This election was the result of a recall petition filed with the City Clerk's office in accordance with the Nixa Home Rule Charter. The question on the ballot read as follows: *Shall Brian Steele, Mayor of the City of Nixa, be removed from office?*

On November 5th, 2021, the Christian County Clerk, Kay Brown certified the results of the election return for the City of Nixa, Christian County, Missouri.

<u>Analysis</u>

Upon certification of the election results, the final full and accurate return of all votes cast were: 808 YES VOTES 2,458 NO VOTES

In accordance with Nixa Home Rule Charter, Section 10.7 Results of Election, if a majority of the qualified electors voting at a recall election shall vote against the proposition to remove an official, the official shall remain in office.


