Background

Currently in the 2022 proposed budget the parks department has requested funding to remove and replace the pavilion at Rotary Park. This pavilion has been a part of the community since the 1960's and has served the community well.

Analysis

T-Mobile is offering grant opportunities for communities under 50,000 people, and the project must be shovel ready. We believe the pavilion would be a perfect fit for this grant opportunity. The grant amount cannot exceed \$50,000.

Recommendation

Staff would like to apply for this grant in the amount of \$30,000 for the removal and replacement of the Rotary Park Pavilion, and if awarded the ability to accept this grant on behalf of the city.
