

RE: Amending the 2023 Annual Budget to Appropriate Funds for Outdoor Lighting Improvements

Background:

In July of 2022, the City of Nixa contracted with Lynn's Electric to complete upgrades to the City Hall outdoor lighting as a budgeted capital improvement project. These improvements included replacement of the existing south outdoor lights with the installation of LED, color-changing outdoor lights and the installation of additional lights to enhance current lighting to reduce security issues.

Analysis:

Due to supply chain delays, installation of the project did not begin until December. There are still few adjustments being made to the control panel of the LED, color-changing lights but we are hoping the project to be completed within the next few weeks. Since the project was not completed as planned in 2022, this budget amendment is to carry over the funds allocated and contracted in 2022 to the 2023 budget for final payment once the work is complete.

Recommendation:

Staff recommends approval of the budget amendment to transfer the remaining \$7100.00 that was originally budgeted in 2022 to the 2023 budget for final payment once the project is completed. Thank you for your consideration.
