

# RE: 2023 Budgetary Amendment for the addition of two police officer positions

## Background:

In April of 2023 the citizens of Nixa passed a <sup>3</sup>/<sub>4</sub> cent sales tax to help fund public safety. One of the goals of this sales tax initiative was to fund additional police officers. In an effort to start addressing the staffing shortages in the police department, the mayor and city council recommended a budgetary amendment be drafted to cover the costs of hiring and employing two additional police officers in fiscal year 2023.

### Analysis:

Because these positions will be added mid-year, the salary and benefits totals for the budgetary amendment were calculated for the six months of fiscal year 2023. Whereas the equipment costs were calculated based on the number of officers added. The total amount of the budgetary amendment will be \$90,041.00. These costs are broken down in council bill exhibit A.

The cost of an additional police vehicle was not included in this budgetary amendment because it was very unlikely the department could procure a vehicle for purchase in fiscal year 2023. The addition of a police vehicle will be addressed in a future annual budget.

The source of funding for this budget amendment is current revenues.

The addition of two police officers will bring the total number of sworn police officers to 44.

### **Recommendation:**

It is the police department staff's recommendation this budgetary amendment be approved.

8	governing body adopts a measure setting forth the facts and reasons making the increase
9	necessary and authorizing the increase; and

11	WHEREAS Section 8.7 of the City Charter authorizes the City Council to amend
12	budgeted revenues and expenditures upon the request of the City Administrator; and

14	WHEREAS the City Administrator has requested a budget amendment as
15	reflected in "Council Bill Exhibit A" and for the purposes referenced therein; and

17	WHEREAS the City Council desires to amend the City's 2023 budget for the

20	NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF
20	NIXA, AS FOLLOWS, THAT:

22	SECTION 1: The City of Nixa's 2023 Annual Budget is hereby amended in the

31	<b>CECTION 2.</b> This Ordinance shall be in full fares and effect on July 1, 2022, subject
32	<b>SECTION 3:</b> This Ordinance shall be in full force and effect on July 1, 2023, subject to the provisions of application 2, 11(r) of the City Charter
