

RE: Budget Amendment for Design work to Relocate Utility Billing to City Hall

Background:

In April 2023, the citizens of Nixa passed a $\frac{3}{4}$ cent general fund sales tax increase for public safety. This increase will allow us to hire additional officers as well as build a new police department. Before a new police department can be built, we must move the utility billing department to city hall and demolish the current utility billing department building to make room for the new police department.

Analysis:

In order to move utility billing, we must first complete a redesign of City Hall. Insight Design Architects provided a quote for the design work that included 2 packages. The first package is \$18,750 and includes the design to relocate Utility Billing to City Hall and includes a program analysis with the Utility Billing Department to determine the space requirements. Package 2 is \$41,500 and includes the remodel of several areas that need to be improved for efficiency, improved work environment and includes a possible new entry structure and exterior smoking area. The cost for both packages would be \$60,250. I believe the best use of resources would be to move forward with both packages to get a full understanding of the needed renovations of City Hall. Therefore, I am requesting the use of ARPA funds to complete the design work. This would require a budget amendment in the amount of \$60,250. Completing this design work will allow us to appropriately budget for the necessary improvements in the 2024 budget.

Recommendation:

Staff recommends the approval of the ordinance for a budget amendment for \$60,250 of ARPA funds to pay for the design work for necessary improvements and to relocate Utility Billing to City Hall. The first reading of the ordinance was held on June 12th.

1 **AN ORDINANCE OF THE COUNCIL OF THE CITY OF NIXA AMENDING THE 2023**
2 **ANNUAL BUDGET TO APPROPRIATE FUNDS FOR DESIGN WORK TO CITY HALL.**

5 **WHEREAS** Section 67.040 RSMo. provides that after a budget has been approved
6 no increase in the revenues or expenditures from any fund shall be made unless the
7 governing body adopts a measure setting forth the facts and reasons making the increase
8 necessary and authorizing the increase; and

10 **WHEREAS** Section 8.7 of the City Charter authorizes the City Council to amend
11 budgeted revenues and expenditures upon the request of the City Administrator; and
12

13 **WHEREAS** the City Administrator has requested a budget amendment as
14 reflected in "Council Bill Exhibit A" and for the purposes referenced therein; and

16 **WHEREAS** the City Council desires to amend the City's 2023 budget for the
17 purposes identified herein.

19 **NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF**
20 **NIXA, AS FOLLOWS, THAT:**

22 **SECTION 1:** The City of Nixa's 2023 Annual Budget is hereby amended in the
23 accounts and the amounts as shown on "Council Bill Exhibit A," which is attached hereto
24 and incorporated herein by this reference.

26 **SECTION 2:** City Council finds that the budget amendment enacted by this
27 Ordinance has been recommended by the City Administrator. The City Administrator is
28 directed to cause the appropriate accounting entries to be made in the books and records
29 of the City to reflect the budget amendment enacted by this Ordinance.

31 **SECTION 3:** This Ordinance shall be in full force and effect on July 1, 2023, subject
32 to the provisions of section 3.11(g) of the City Charter.
