

# RE: Intergovernmental Agreement and Budgetary Amendment for MOSWIN RADIO Project

## Background:

For many years now, Christian County E911 has worked to improve the reliability of law enforcement communications throughout the county. During this time, the organization concluded the current radio system used by all law enforcement in Christian County was inadequate. Law enforcement agencies experienced lack of coverage, capacity issues and interoperability problems.

Christian County E911 was tasked to come up with a working solution to these issues. After much research and debate, it was concluded that the state operated public safety radio system called MOSWIN was the most viable solution. By joining the MOSWIN radio system Christian County E911 can solve all our law enforcement radio communications issues.

Through the hard work and dedication of members assigned to this radio project, a working plan to implement the MOSWIN radio system in Christian County was developed. However, this plan came with a price tag of \$10.32 million dollars. Fortunately, Christian County E911 was able to secure 8.5 million dollars in federal appropriations in the form of a grant. This left a \$1.82 million dollar shortfall for the project to be fully funded.

With no other prospects to cover the shortfall, Christian County E911 is asking Christian County stakeholders to participate in an equitable sharing effort to fund the \$1.82 million dollar shortfall. Using a mathematical formula based on jurisdictional population, the shortfall was divided equitably among the county's law enforcement agencies.

Christian County E911 has requested the City of Nixa enter into an intergovernmental agreement to pay Christian County E911 \$261,886.45 as their portion of the MOSWIN radio project.

# Analysis:

By participating in this intragovernmental agreement, the City of Nixa can ensure the Nixa Police Department is communicating on the best radio system available. All the shortcomings of the current radio system will be alleviated.

Without the cost sharing agreements in place to fund the shortfall, Christian County E911 will lose the \$8.5 million dollar funding putting this new radio system out of reach for many years and leave law enforcement and E911 in a position to find alternative





funding. The federal funds Christian County E911 has secured for this project has been called an "once in a lifetime" opportunity to implement a state-of-the-art radio system that benefits every citizen in Christian County.

This budgetary amendment is eligible for ARPA funds expenditure, and it is the recommendation of staff to use APRA funds for this project.

#### Recommendation:

It is the recommendation of the Police Department staff to approve this intergovernmental agreement and budgetary amendment.

AN ORDINANCE OF THE COUNCIL OF THE CITY OF NIXA AUTHORIZING THE 1 MAYOR TO EXECUTE AN INTERGOVERNMENTAL COOPERATIVE AGREEMENT 2 WITH CHRISTIAN COUNTY EMERGENCY SERVICES AND SEVERAL OTHER 3 4 LOCAL JURISDICTIONS AND AMENDING THE 2023 ANNUAL BUDGET FOR THE 5 PURPOSE OF FUNDING THE MOSWIN RADIO SYSTEM PROJECT. 6 7 WHEREAS Section 70.220 RSMo. authorizes units of government to cooperate 8 9 with one another and to enter into intergovernmental cooperative agreements for such purposes; and 10 11 12 **WHEREAS** the City Council desires to contract with Christian County Emergency Services, and several other local-Christian County governmental units, to fund a portion 13 of the MOSWIN radio project; and 14 15 WHEREAS said project is anticipated to enhance the emergency radio 16 17 communication systems and capabilities of law enforcement within Christian County; and 18 WHEREAS the City Council desires to authorize the Mayor to execute an 19 20 Intergovernmental Cooperative Agreement with Christian County Emergency Services, and several other local-Christian County governmental units, said Agreement to be 21 22 substantially similar to the document attached hereto as "Council Bill Exhibit A": and 23 WHEREAS Section 67.040 RSMo. provides that after a budget has been approved 24 no increase in the revenues or expenditures from any fund shall be made unless the 25 26 governing body adopts a measure setting forth the facts and reasons making the increase 27 necessary and authorizing the increase; and 28 29 WHEREAS Section 8.7 of the City Charter authorizes the City Council to amend 30 budgeted revenues and expenditures upon the request of the City Administrator; and 31 WHEREAS the City Administrator has requested a budget amendment in the 32 33 amount of \$261,886.45, as reflected in "Council Bill Exhibit B," and for the purposes referenced therein: and 34 35 WHEREAS the City Council desires to amend the City's 2023 budget for the 36 purposes identified herein. 37 38 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF 39 NIXA, AS FOLLOWS, THAT: 40 41 42 **SECTION 1:** The Mayor, or designee, is hereby authorized and directed to execute an "Intergovernmental Cooperative Agreement" (the "Contract") with Christian County 43 Emergency Services, Christian County, Missouri, the City of Ozark, Missouri, the City of 44 45 Clever, Missouri, the City of Sparta, Missouri, the City of Billings, Missouri, and the City of Highlandville, Missouri. #### **INTERGOVERNMENTAL COOPERATIVE AGREEMENT**

THIS INTERGOVERNMENTAL COOPERATIVE AGREEMENT ("IGA"), made and entered into this \_\_\_\_\_\_\_ day of \_\_\_\_\_\_\_, 2023, by and between CHRISTIAN COUNTY EMERGENCY SERVICES, a Missouri countywide emergency services district established in accordance with Section 190.339, RSMo. (hereinafter referred to as "CCES") and CHRISTIAN COUNTY, MISSOURI, a Missouri county of the first class; the CITY OF NIXA, MISSOURI, a constitutional charter city in Christian County; the CITY OF OZARK, MISSOURI, a city of the \_\_\_\_\_ class located in Christian County; the CITY OF CLEVER, MISSOURI, a city of the \_\_\_\_\_ class; the CITY OF SPARTA, MISSOURI, a city of the \_\_\_\_\_ class; the CITY OF BILLINGS, MISSOURI, a city of the \_\_\_\_\_ class; and the CITY OF HIGHLANDVILLE, MISSOURI, a city of the \_\_\_\_\_ class (hereinafter collectively "the Parties"). The parties except for CCES will be referred to as the "Participants."

#### WITNESSETH:

WHEREAS, Section 70.220, RSMo., authorizes units of government to cooperate with one another and to enter into intergovernmental cooperative agreements; and

WHEREAS, CCES and Participants have agreed to cooperate and jointly fund a portion of the cost of the "MOSWIN" radio update project that is to be implemented in Christian County to enhance the emergency radio communications systems and capabilities of law enforcement in the County and each of the Participant cities (hereinafter "the Project"); and

WHEREAS, this Intergovernmental Cooperative Agreement is entered into to memorialize the agreement between the parties pertaining to the subject matter hereof.

NOW, THEREFORE, the parties do hereby mutually covenant and agree as

follows:

- 1. CCES has entered into a contract with Motorola Solutions, Inc. to deliver and install an advanced radio communications system, hardware and infrastructure, as more fully defined in the Proposal by Motorola dated November 16, 2022, and the Contract signed by CCES and Motorola dated December 29, 2022 in the amount of \$9,382,779.31. This Project was planned and designed to allow CCES and the Participants to connect to the statewide "MOSWIN" emergency radio communications system. CCES has also applied for and received approval for federal and state funding for a substantial portion of the cost of this Project.
- 2. CCES has determined, in cooperation with Motorola, that in order to complete the Project, additional shelters, generators and HVAC units are required at the tower sites that will support and serve the Project. The cost of this portion of the work is described on "Change Order 001" attached hereto and incorporated herein by reference.
- 3. Each of the Parties agree to contribute a portion of the cost of this Change Order work, in the following amounts, to be paid on or before

to CCES:

4. CCES agrees that upon receipt of a fully executed copy of this Agreement, that it will execute Change Order 001 and direct Motorola to proceed with the performance of the work; that it will fully comply with all applicable federal and state laws in the performance of the work of the Project; and that it will apply the full amount of the funds contributed by each of the Parties to the payment of Change Order 001.

- 5. CCES agrees that each of the parties shall have the right to review and inspect the books and records of CCES to ensure the correct and proper application of these funds, as described in this Agreement.
- 6. This Agreement is entered into by the parties in order to allow each of them to provide efficient and effective radio communications systems for law enforcement and emergency services. Thus, it is fully within the powers of each of the parties.
- 7. In no event shall this Agreement, or any term hereof, be interpreted or construed to be a waiver or limitation of the sovereign, governmental or official immunities of any of the Parties, as provided by state or federal law.
- 8. This document contains the entire agreement between the parties. No modification, amendment, cancellation, or waiver of any provision of this Agreement shall be effective unless it is in writing, authorized by each party, and signed by an authorized representative.
- 9. Each of the undersigned was fully authorized and empowered to execute this Agreement by each of their respective Boards.
