

Memorandum Regarding Council Bill No. 2024-02: An Ordinance establishing an appointments committee of the City Council.

Background:

At the December 11, 2023, regular meeting of the City Council, Mayor Giddens discussed with the Council the prospect of establishing a standing committee of the Council to consider mayoral appointments to the planning and zoning commission. At the conclusion of this discussion, city staff were directed by the Council to draft and present a Council Bill establishing such a committee.

Analysis:

The provisions of Council Bill 2024-02 modify the City Code to establish an appointments committee.

The appointments committee will be charged with reviewing and making recommendations on the mayor's proposed appointments to the planning and zoning commission. This duty is triggered upon the mayor's written referral to the committee of proposed appointments. The committee will have 30 days from the date of the mayor's referral to provide recommendations on such appointments to the full city council.

Additionally, this Bill modifies Section 2-43 of the City Code. The amendments to this section include placing the mayor on each committee as an ex officio nonvoting member, providing for how members of council committees are appointed, and providing that the mayor is authorized to appoint the chairs of committees with the advice and consent of the council. Further, language has been added to Section 2-43 to provide a mechanism in which the council may remove members of standing or special committees.

Recommendation:

City staff believes that the proposed Bill accomplishes the policy objective sought by the Mayor and City Council and therefore recommends approval.

AN ORDINANCE OF THE COUNCIL OF THE CITY OF NIXA AMENDING CHAPTER 2. 1 ARTICLE II, DIVISION 5, SECTIONS 2-40 AND 2-43 FOR THE PURPOSE OF 2 ESTABLISHING AN APPOINTMENTS COMMITTEE OF THE COUNCIL AND 3 ADOPTING PROCEDURES RELATED THERETO. 4 5 6 WHEREAS Mayor Giddens, at the December 11, 2023, regular meeting of the City 7 Council discussed the Planning and Zoning Commission appointment process with the 8 9 City Council; and 10 11 WHEREAS the Council discussed the possibility of establishing a Council committee to review mayoral appointments to the Planning and Zoning Commission prior 12 to said appointments being heard by the full Council; and 13 14 WHEREAS at Council's direction, staff has prepared amendments to the City Code 15 to establish a standing appointment committee to review the Mayor's appointments to the 16 17 Planning and Zoning Commission; and 18 WHEREAS while drafting these amendments, staff determined that additional 19 20 amendments were needed to Chapter 2, Article II, Division 5 of the City Code; and 21 **WHEREAS** the City Council desires to modify the City Code as set forth herein. 22 23 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF 24 NIXA, AS FOLLOWS, THAT: 25 26 **SECTION 1:** Chapter 2, Article II, Division 5, Section 2-40 of the Nixa City Code is 27 hereby amended by repealing said section in its entirety and adopting in lieu thereof a 28 new Section 2-40, said section shall read as follows: 29 30 (Note: Language to be added is indicated by being underlined. Language to be removed 31 is indicated by being stricken.) 32 33 Sec. 2-40. – Standing committees. 34 35 There is hereby established the following standing committees of the city council: 36 37 (a) Appointments Committee. There is hereby established an appointments committee 38 which shall be comprised of three members of the City Council and shall carry out the 39 following duties: 40 41 (1) Upon written referral by the mayor, the committee shall review and make 42 recommendations on the mayor's proposed appointments to the planning and 43 zoning commission. 44 45

46	(2) The committee shall, within 30 days of a written referral from the mayor, provide			
47	recommendations on the mayor's proposed appointments to the city council. If the			
48	committee shall fail to provide recommendations within 30 days, the mayor may			
49	submit their proposed appointments to the full city council.

99	subsection numbers, or internal citation references are in error or are contrary to the intent			
100	of this Ordinance.		-

102	SECTION 4: Savings Clause. Not	thing in this Ordinance sha	Il be construed to	
103	affect any suit or proceeding now pending in any court or any rights acquired, or liability			
104	incurred nor any cause or causes of action occurred or existing, under any act or

107	SECTION 5: Severability Clause. If any section, subsection, sentence, clause, or			
108	phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect			
109	the validity of the remaining portions of this Ordinance. The Council hereby declares that			
110	it would have adopted the Ordinance and each section, subsection, sentence, clause, or			
111	phrase thereof, irrespective of the fact that any one or more sections, subsections,			
112	sentences, clauses, or phrases be declared invalid.

114	SECTION 6: This Ordinance shall be in full force and effect from and after its final			
115	passage by the City Council and after its approval by the Mayor, subject to the provisions			
116	of section 3.11(g) of the City Charter.
