

Memorandum Regarding Council Bill No. 2024-03: An Ordinance calling for an election to be held on April 2, 2024, to ask the voters to approve an additional three percent sales tax on non-medical adult use marijuana and imposing said tax if approved.

Background:

On November 8, 2022, the electors of the State of Missouri approved Amendment 3 to the Missouri Constitution. Amendment 3 enacted Section 2 of Article XIV of the Missouri Constitution effective December 8, 2022. Article XIV, Section 2.6(5) authorizes cities to impose an additional sales tax in an amount not to exceed three percent on all tangible personal retail sales of non-medical adult use marijuana sold within the corporate limits of the city subject to approval by the voters of the city.

Analysis:

Council Bill 2024-03, if approved, would submit to the voters of the City of Nixa the question of whether to authorize an additional sales tax of three percent on all tangible personal property retail sales of non-medical adult use marijuana. This question would be submitted at the April 2, 2024, general municipal election.

Recommendation:

Staff recommends approval of this Council Bill.

AN ORDINANCE OF THE COUNCIL OF THE CITY OF NIXA CALLING AN ELECTION 1 TO BE HELD ON APRIL 2, 2024, TO SUBMIT TO THE QUALIFIED VOTERS THE 2 QUESTION OF IMPOSING AN ADDITIONAL THREE PERCENT SALES TAX ON ALL 3 TANGIBLE PERSONAL PROPERTY RETAIL SALES OF NON-MEDICAL ADULT USE 4 MARIJUANA; AUTHORIZING THE CITY CLERK TO DO ALL THINGS NECESSARY 5 AND CONVENIENT TO SUBMIT SAID QUESTION TO THE QUALIFIED VOTERS OF 6 THE CITY; AND PROVIDING FOR THE ENACTMENT OF SAID TAX IF APPROVED. 7 8 9 WHEREAS the City is authorized pursuant to the Article XIV, Section 2, of the 10 11 Missouri Constitution to impose an additional sales tax in an amount not to exceed three precent on all tangible personal property retail sales of non-medical adult use marijuana 12 sold within the City, subject to approval by the qualified voters of the City; and 13 14 WHEREAS the City Council finds that it is in the best interest of the citizens of the 15 City to impose an additional sales tax of three percent on all tangible personal property 16 17 retail sales of non-medical adult use marijuana sold in the City and to submit the same to the qualified voters of the City for approval of those voting at the general municipal 18 election to be held on April 2, 2024. 19 20 NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF 21 NIXA, AS FOLLOWS, THAT: 22 23 **SECTION 1:** An election is hereby called and ordered to be held within the City of 24 Nixa, Missouri, on April 2, 2024, to submit the following question to the qualified voters of 25 26 the Citv: 27 **QUESTION 1** 28 29 Shall the City of Nixa, Missouri, impose an additional sales tax of three 30 percent (3%) on all tangible personal property retail sales of non-medical 31 adult use marijuana sold within the City? 32 33 Yes [] 34 No [] 35 36 37 Instructions to Voters: If you are in favor of the question, place an X in the box opposite "YES." If you are opposed to the question, place an X in the 38 39 box opposite "NO." 40 **SECTION 2:** The City Clerk is authorized and directed to notify the Clerk of 41 42 Christian County, Missouri of the adoption of this Ordinance as soon as practicable, but 43 no later than 5:00 p.m. on the tenth Tuesday prior to April 2, 2024, and to include in said notification all of the terms and provisions required by Chapter 115, RSMo., or any other 44 45 provision of law. The City Clerk is further authorized and directed to do all things necessary and convenient to ensure that the question is properly submitted to the voters 46

on April 2, 2024, including, without limitation, submitting a different ballot from the form
approved Section 1 of this Ordinance, so long as the question submitted to the voters is
substantially the same as the question authorized in Section 1 of this Ordinance. The City
Clerk shall also provide a certified copy of the notice of election, which is attached hereto
as "Council Bill Exhibit A." Said notice of election shall be in substantially similar form as
the document attached hereto as "Council Bill Exhibit A."

54 **SECTION 3:** The Clerk of Christian County, Missouri is hereby authorized to 55 conduct an election on behalf of the City in a manner consistent with the provisions of 56 Chapter 115, RSMo.

58 **SECTION 4:** The City Administrator, and other officers of the City, are hereby 59 authorized and directed to take such other actions as may be necessary or convenient to 60 carry out the purpose and intent of this Ordinance.

62 **SECTION 5:** Upon approval, by the qualified voters of the City, of the question 63 herein submitted by this Ordinance the additional sales tax contemplated herein shall be 64 levied, in addition to any other sales taxes levied by the City, within the City limits of the 65 City of Nixa, Missouri. The City Administrator, or designee, shall thereafter be authorized 66 and directed to provide certified copies of this Ordinance, and any other information which 67 may be necessary or convenient, to the Director of Revenue of the State of Missouri. 68

69 **SECTION 6:** If the proposed city sales tax is not approved by a majority of the 70 votes cast by the qualified voters voting thereon, then this Ordinance shall be of no effect, 71 and the sales tax proposed herein shall not be effective, however, the failure of this 72 proposition to receive the requisite majority vote shall have no effect on any other sales 73 tax levied or imposed by the City. Nothing herein is intended to be nor shall be deemed 74 as an abolition of any other tax levied by the City.

SECTION 7: This Ordinance shall be in full force and effect from and after its final
 passage by the City Council and after its approval by the Mayor, subject to the provisions
 of section 3.11(g) of the City Charter.
