

AN ORDINANCE OF THE NIXA CITY COUNCIL TO VACATE RIGHT-OF-WAY THAT IS GENERALLY LOCATED IN THE VILLAGE OF WOODENBRIDGE AT WICKLOW, WICKLOW SCHOOL (VILLAGE OF CLOVERHILL) AND OLD CASTLE ESTATES PHASE 7

Background:

In 1996 a right-of-Way was established for a North-South road through what would become several Wicklow neighborhoods. As the plans for the Wicklow development changed over time, Old Castle Road emerged as the primary North-South road through the development. However, the original right-of-way for the unnamed and unbuilt road was never vacated.

Analysis:

The vacation of this right-of-way will have no real effect on the properties through which the right-of-way currently exists. As it is now, the right-of-way could appear on title paperwork for transactions involving homes and properties which may cause confusion or delays. It is apparent this road will never be built, so the presence of this right-of-way is decidedly unnecessary.

Planning and Zoning Commission:

A public hearing for this item was held at the April 2nd Planning and Zoning Commission meeting. One individual approached the commission to inquire if there were other unknown recorded documents that he needed to be worried about. The P&Z Commission voted unanimously (6-0) to approve the agenda item. At the time of the vote, staff thought that P&Z was the final decision on the agenda item. Staff now prefer that the City Council make the final determination on vacating right-of-way.

Recommendation:

Planning staff is in support of vacating this right-of-way and recommends approval.

 AN ORDINANCE OF THE COUNCIL OF THE CITY OF NIXA VACATING CERTAIN RIGHT-OF-WAY WITHIN THE SUBDIVISIONS OF THE VILLAGE OF WOODENBRIDGE AT WICKLOW, WICKLOW SCHOOL (VILLAGE OF CLOVERHILL), AND OLD CASTLE ESTATES PHASE 7.

WHEREAS in 1996 a certain right-of-way with a legal description shown on Council Bill Exhibit A, attached hereto, and shown on a map attached hereto as Council Bill Exhibit B, was established for the City to build a North-South road through what would become several Wicklow neighborhoods; and

WHEREAS over the course of time and as the Wicklow development plans changed, that road was not built and will not be built as Old Castle Road has emerged as the primary North-South road through the development; and

WHEREAS the City has taken no action to use the right-of-way for the unbuilt road, but since several homes and improvements have been placed through the area over time, the road will not now need to be built, but the original right-of-way was never vacated; and

WHEREAS the possibility the right-of-way, recorded at Book 310, Page 8971 in the records of the Recorder of Deeds of Christian County, Missouri, could appear in title searches for transactions on properties in that area and cause confusion and delay has led staff to recommend the City vacate this right-of-way; and

WHEREAS the Planning and Zoning Commission considered this matter at their meeting of April 2, 2025, and, after considering the recommendation of staff, the proposal to vacate, and public comment, voted 6-0 to approve vacating this right-of-way; and

WHEREAS the City Council desires to approve vacating the right-of-way as set forth herein and authorize the City Administrator to execute all necessary documents.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:

SECTION 1: The City Council hereby vacates and relinquishes the right-of-way described on "Council Bill Exhibit A," which is attached hereto and incorporated herein by this reference, and which is located within the subdivisions of the Village of Woodenbridge at Wicklow, Wicklow School (Village of Cloverhill), and Old Castle Estates Phase 7.

SECTION 2: The City Administrator and the officers of the City are hereby authorized to do all things necessary or convenient to carry out the terms and intent of this Ordinance.

SECTION 3: Savings Clause. Nothing in this Ordinance shall be construed to affect any suit or proceeding now pending in any court or any rights acquired, or liability

incurred nor any cause or causes of action occurred or existing, under any act or ordinance repealed hereby.

SECTION 4: Severability Clause. If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be invalid, such decision shall not affect the validity of the remaining portions of this Ordinance. The Council hereby declares that it would have adopted the Ordinance and each section, subsection, sentence, clause, or phrase thereof, irrespective of the fact that any one or more sections, subsections, sentences, clauses, or phrases be declared invalid.

SECTION 5: This Ordinance shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions of section 3.11(g) of the City Charter.
