

Re: Declaring the Results of the April 8, 2025 General Municipal Election

Background:

According to Section 9.3 of the Charter, the City Council is required to declare the results of all municipal elections. Council is required to declare those results at the next regularly scheduled City Council meeting after the election authority has certified the election results.

The Christian County Clerk, the election authority for Christian County and the City, has provided the certification of the election to the City.

Analysis:

Now that the City is in receipt of the certified election results, the Council is required by Charter to declare those results. The individuals who received the most votes are required to be sworn into office.

Recommendation:

Staff recommends approval of the resolution due to the Charter requirement that Council declare the results of the election.
