### **Background:**

Staff is seeking authorization to purchase a new excavator, authorized with the 2025 budget.

### **Analysis:**

In the 2025 CIP and budget, the water department requested a new excavator capable of digging down 15 feet to reach infrastructure in town and on the RDE system that are too deep for a backhoe. This allows us not to be so dependent on rental companies and to have equipment on hand in case of an emergency. This piece of equipment was approved by council for 2025. We plan to purchase it through the SourceWell contract we use from time to time to purchase equipment. The unit we seek to purchase will be delivered in 2025

**WHEREAS** the Nixa City Code authorizes the City to participate in cooperative purchasing arrangements provided that, when a cooperative purchase exceeds \$10,000.00, the purchase must be submitted to City Council for approval; and

**WHEREAS** City Council desires to authorize the City Administrator to utilize a SourceWell cooperative contract for the purchase of a new excavator for use by the City's Water Department.

**NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:**

**SECTION 1:** The City Council hereby authorizes the City Administrator, or designee, to purchase a new excavator, as described on "Resolution Exhibit A," which is attached hereto and incorporated herein by this reference. The City Administrator and the officers of the City are hereby authorized to do all things necessary or convenient to carry out the terms and intent of this Resolution.

**SECTION2:** This Resolution shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions of section 3.11(g) of the City Charter.
