

Re: Declaring the Results of the August 5, 2025 Special Municipal Election

Background:

According to Section 9.3 of the Charter, the City Council is required to declare the results of all municipal elections. Council is required to declare those results at the next regularly scheduled City Council meeting after the election authority has certified the election results.

The Christian County Clerk, the election authority for Christian County and the City, has provided the certification of the election to the City.

Analysis:

The candidate that received the most votes at the August 5th Special Election was disqualified from running in the election by the Missouri Ethics Commission on June 10th, 2025. The candidate submitted a letter of resignation for the District 1 seat to my office on August 15th, 2025. Due to the disqualification from the Missouri Ethics Commission and the letter of resignation, the District 1 Council Member position is still vacant.

Mayor Giddens has recommended Mr. Jay Ortiz for the vacant position.

Recommendation:

Staff recommends approval of the resolution to declare the election results and fill the vacant District 1 position.

A RESOLUTION OF THE COUNCIL OF THE CITY OF NIXA DECLARING THE RESULTS OF THE AUGUST 5, 2025, SPECIAL MUNICIPAL ELECTION; DECLARING A VACANCY IN THE DISTRICT 1 CITY COUNCIL SEAT; AND FILLING SAID VACANCY WITH THE APPOINTMENT OF JAY ORTIZ.

WHEREAS a Municipal Election was held within the City of Nixa on August 5, 2025; and

WHEREAS the official returns of said election have been certified by the Christian County Clerk and provided to the City, said certification is attached hereto and incorporated herein by this reference as "Resolution Exhibit A;" and

WHEREAS Section 9.3 of the City Charter requires the City Council to declare the results of any municipal election following certification of said election at the next regularly scheduled Council meeting; and

WHEREAS to comply with the requirements of the City Charter and State Law, the City Council desires to declare the results of said election; and

WHEREAS the candidate receiving the most votes at said election submitted a letter of resignation to the City Clerk on August 15, 2025, a copy of said correspondence is attached hereto as "Resolution Exhibit B;" and

WHEREAS the Executive Director of the Missouri Ethics Commission, on June 10, 2025, notified the City Clerk that said candidate was no longer qualified to run for the office they sought, a copy of said correspondence is attached hereto as "Resolution Exhibit C;" and

WHEREAS because of the Executive Director of the Commission's determination and the subsequent resignation of the candidate, the Council finds and declares the office of Councilmember for District I is vacant; and

WHEREAS pursuant to Section 3.6 of the Nixa City Charter, the Council desires to fill the vacancy with the appointment of Mr. Jay Ortiz.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:

SECTION 1: The election herein referred to has been found to have been held in all respects as required by the laws of the State of Missouri and the Charter and Ordinances of the City of Nixa, at designated voting places, that all qualified electors of the City and no others were permitted to vote, and that the results of the election is found and declared as follows:



Dear Election Filing Official:

Based on information received by our office, it is our understanding that your office received a declaration of candidacy for the August 5, 2025, election from the following candidate(s):

Brian Popejoy Candidate City Council

This candidate failed to file their personal financial disclosure statement on or by May 20, 2025, the deadline for filing, to avoid disqualification from the ballot.

Please note that Section 105.492.2, RSMo. provides:

"If a candidate for office does not file a financial interest statement by the close of business on the twenty-first day after the last day for filing for election for which the person is a candidate, the commission shall notify the official who accepted such candidate's declaration of candidacy that the candidate is disqualified. Such election official shall remove the candidate's name from the ballot."

While it has been the practice of Commission for the Commissioners to meet in open session to vote to notify the election official of that the candidate failed to file personal financial statement and is therefore disqualified, the Commission lacks a quorum to meet and to take any action as required by 105.955.6, RSMo. Because it is unclear when the Commission will have enough Commissioners to meet, we wanted to make you aware of the failure of this candidate to file the personal financial statement by the required deadline. We suggest that you consult with your legal counsel regarding this issue.
