

RESOLUTION OF THE NIXA CITY COUNCIL CONFIRMING THE APPOINTMENT OF ETHAN IVES TO THE PLANNING AND ZONING COMMISSION

Background:

The Planning and Zoning Commission has been one member short since the resignation of Charity Fitzgerald in May of 2025. The Appointments Committee met on September 29, 2025, and during the open meeting, five potential appointees were interviewed or given consideration by the Committee.

Analysis:

After much deliberation, the Appointments Committee selected Ethan Ives to serve on the Planning and Zoning Commission. Mr. Ives will start a new 4-year term starting November 1, 2025, which is when Mrs. Fitzgerald term expires. His term will run until November of 2029.

A RESOLUTION OF THE COUNCIL OF THE CITY OF NIXA CONSENTING TO THE MAYOR'S APPOINTMENT OF ETHAN IVES TO THE PLANNING AND ZONING COMMISSION.

WHEREAS Charity Fitzgerald resigned from the Planning and Zoning Commission in May of 2025; and

WHEREAS Ms. Fitzgerald's term was set to expire on November 1, 2025; and

WHEREAS the Mayor submitted several potential Commission appointments to the City Council Appointments Committee for their review, pursuant to Section 2-40 of the Nixa City Code; and

WHEREAS at the Appointments Committee meeting of September 29, 2025, the Committee recommended the appointment of Ethan Ives to the Commission; and

WHEREAS the Mayor, based on the recommendation of the Appointments Committee, has appointed Ethan Ives to serve on the Commission starting November 1, 2025, with his term to run until November 1, 2029; and

WHEREAS the City Council hereby consents to the Mayor's appointment as provided for herein.

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE CITY OF NIXA, AS FOLLOWS, THAT:

SECTION 1: The City Council hereby consents to the Mayor's appointment of Ethan Ives to the City's Planning and Zoning Commission. Mr. Ives's term shall begin on November 1, 2025, and shall expire on November 1, 2029.

SECTION 2: This Resolution shall be in full force and effect from and after its final passage by the City Council and after its approval by the Mayor, subject to the provisions of section 3.11(g) of the City Charter.
