

RESOLUTION OF THE NIXA CITY COUNCIL CONFIRMING THE APPOINTMENT OF ETHAN IVES TO THE PLANNING AND ZONING COMMISSION

Background:

The Planning and Zoning Commission has been one member short since the resignation of Charity Fitzgerald in May of 2025. The Appointments Committee met on September 29, 2025, and during the open meeting, five potential appointees were interviewed or given consideration by the Committee.

Analysis:

After much deliberation, the Appointments Committee selected Ethan Ives to serve on the Planning and Zoning Commission. Mr. Ives will start a new 4-year term starting November 1, 2025, which is when Mrs. Fitzgerald term expires. His term will run until November of 2029.

17 18 19 20	WHEREAS the Mayor, based on the recommendation of the Appointments Committee, has appointed Ethan Ives to serve on the Commission starting November 1 2025, with his term to run until November 1, 2029; and
