# **RE: SUMMER PEAKING POWER PURCHASE**

# Background:

The city has been provided an opportunity to purchase peaking power for this summer to potentially offset summer peak power purchase pricing. Priority Power is the consulting firm that Nixa uses to help manage our power purchase contracts and help find solutions to deliver the most cost-effective energy to our customers. They are continually monitoring our energy load factors and searching for opportunities to lower our energy purchase prices. Over the past few years, Priority Power has been working with Nixa regarding our summer peaking loads. As the city grows, we are becoming more suspectable to summer peak loads and the price increase that comes along with hotter weather in the summer. One way to offset the potential price increases that come with summertime peaking is to enter into a Peaking Power Purchase contract for a defined amount of time and for certain hours of the day. This year Priority Power has been able to secure a fixed price peak power purchase contract with a company called Evergy who is willing to sell us 5MW at a set price of \$65 per MW from June 1st. through September 30th.

# Analysis:

The attached ordinance will authorize the City Administrator to execute a contract with Evergy power to purchase 5MW of power from June 1, 2025, through September 30, 2025, at a price of \$65 per MW. The power package will be a 5 by 16 power purchase package. What this means is that Nixa will secure 5MW per day for a 16-hour block of each day. This will allow us to not have to go out on the open market during peak hours and potentially pay much higher MW prices to cover our peak load during high heat periods.

### Recommendation:

Staff has been working with our power purchase consultant and after reviewing anticipated gas pricing this summer have determined that purchasing a summer peaking power package is in the best interest of the community and recommends approval of the attached contract.
